Caldwell served city of Pella well

The death of Mayor C.B. "Babe" Caldwell last week ended an era of public service that brought many changes to Pella.

Caldwell was truly a good mayor for several reasons. There was never any question as to what was on his mind or how he felt about a subject. Caldwell was also fair to the people he represented and dealt with. He listened to both sides of an issue, it didn't matter how big or small or who the individuals involved were. If someone had a problem, he would take the time to listen to the complaint.

Under Caldwell's leadership Pella saw many improvements including a \$14 million sanitary sewage treatment plant, a new reservoir, the construction of softball diamonds and expansion of the light plant in the early 1960s. He was also the key in the drive to build Pella's outdoor swimming pool.

Perhaps Caldwell's biggest accomplishments were his part in adopting a sign ordinance and Dutch fronts for businesses and Pella's recreation program. The sign ordinance disallowed hanging signs and prevented the Pella business area from having a cluttered look. That along with the Dutch fronts on buildings gives Pella its unique character. These ideas have been copied by other communities in Iowa.

Pella's recreation system grew from six to 11 parks during Caldwell's time in city government and he was proud of activities available for Pella's youth. Rotary, Kiwanis, Jaycee, Big Rock and Caldwell parks were added during his tenure, with the newest--Caldwell-named for him.

Although Caldwell was not a Pella native, he truly loved the town, calling it the best town in the world. Pella will miss him.
